The Mat-Su Chapter of the Alaska Peace Officers Association (APOA) is an organization made up of local, state, and federal criminal justice professionals. To contribute to the continued improvement of our profession and the community we serve, we are offering competitive academic scholarships.

We will award up to two \$1500 scholarships to students pursuing educational goals with a career in the criminal justice field as the objective. Preference will be given to those planning to pursue a career in Alaska. Previous recipients may apply but are not accorded an advantage in the selection process.

The Scholarship Committee will consider the following criteria when selecting recipients:

- Information submitted on a completed Scholarship Application Form and accompanying essay.
- Current academic grade point average.
- Enrollment at a post-secondary institution (both the UAF Law Enforcement Academy and the UAS Alaska Law Enforcement Training Academy are eligible programs). You may apply before being accepted to a college, but scholarship awards will only be sent to the institution's financial aid office.
- References provided by each applicant.
- Financial need.
- Mat-Su Borough residency will be given preference.
- APOA affiliation will be given preference.

If you have attended college full-time for more than a year, it is not necessary to submit your high school transcript in addition to your college transcript.
